REPORT OF THE CREDENTIALS COMMITTEE TO THE CONFERENCE

(presented by the Chairman of the Credentials Committee)

- 1. At its second meeting, held on 3 September 2008, the Conference established a Credentials Committee, with the delegations of Argentina, Australia, Greece, Indonesia and Nigeria, being invited to nominate members of this Committee, and the Swiss Federal Department of Foreign Affairs providing its services as advisor.
- 2. The Credentials Committee held a first meeting on 4 September 2008, and a second meeting on 5 September 2008, with the Committee being composed as follows:

- 3. On a proposal moved by Greece, the delegate of Nigeria, H.E. Mr Mohammed Kawu Ibrahim, was elected Chairman of the Committee.
- 4. At the plenary meeting of the Conference held on 5 September 2008, the Chairman of the Credentials Committee presented a preliminary Report, informing the Conference that as of 8.30 a.m. of the same day, 50 States and 10 international Organisations and groups had registered for the Conference. Credentials in due and proper form had been submitted by 21 States, one regional economic integration Organisation and five international Organisations and groups. Two States have been accepted as observers. Full powers to sign the international legal instrument to be adopted by the Conference have been presented by three States.
- 5. The Committee recommended to the Conference that, in conformity with Rule 4 of the Rules of Procedure, all delegations registered be permitted to participate in the Conference pending receipt of their credentials in due and proper form; the Conference accepted this recommendation. The Committee nevertheless urged those delegations not having submitted credentials to do so as soon as possible.

- 6. The Credentials Committee held its third meeting on 11 September 2008. In the absence of H.E. Mr Mohammed Kawu Ibrahim, the meeting was chaired by Mr Edosa K. Aigbekaen (Nigeria). At this meeting the Credentials Committee found that three States and four international Organisations and groups had registered for the Conference since its previous meeting. The Committee found that Credentials in due and proper form had been submitted by nine further States, and seven further international Organisations and groups. Nine further States had been accepted as observers. Full powers to sign the international legal instrument to be adopted by the Conference had been presented by three further States (one of which had previously presented Credentials in due and proper form).
- 7. The Credentials Committee held its fourth meeting on 12 September 2008, chaired by Mr Edosa K. Aigbekaen (Nigeria). The Committee found that Credentials in due and proper form had been submitted by five States since its previous meeting. At this meeting, the Credentials Committee found that, in total, 52 States, one regional economic integration Organisation and 13 Organisations had registered for the Conference. The credentials of the delegations of the following 35 States were found to be in due and proper form:
