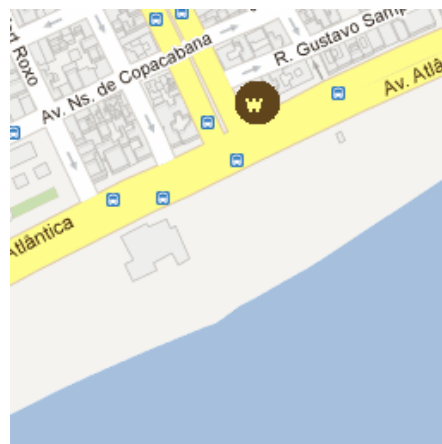

PRACTICAL INFORMATION FOR MEETING PARTICIPANTS

Venue of the Conference

The meeting will be held in Rio de Janeiro, Brazil, at the Hôtel WINDSOR ATLANTICA, Avenida Atlântica, 1020 – Copacabana.



Opening of the meeting

The opening session of the second meeting of the *Committee on emerging markets issues, follow-up and implementation* will be held on Tuesday, 27 March 2012 at 10 a.m. in the Salão Angra dos Reis (Auditorium Angra) of Hotel WINDSOR ATLANTICA.

Registration of participants

In order to streamline the procedure for the registration of participants, a registration form will be sent out by the UNIDROIT Secretariat in advance of the meeting to those whose attendance is officially announced in good time. Conference participants will be able to register in advance by completing this form and returning it to the UNIDROIT Secretariat. The UNIDROIT Secretariat should be informed of the names and functions of those who will be attending the diplomatic Conference as soon as possible, and in any event **no later than 5 March 2012**.

Those meeting participants not able to complete and return this form in advance of the meeting will be able to register on **Tuesday 27 March 2012** at the registration desk located outside the meeting room **from 8 a.m.**

All meeting participants should report to the registration desk on first arriving in order to collect the badge that they will need to wear in order to gain admittance to the meeting room. This badge will need to be worn visibly at all times during the meeting.

Requirements for entering Brazil

Participants should ascertain the requirements for their entry into Brazil and, where necessary, obtain a visa from the Brazilian Embassy or other Mission nearest to them.

The Embassies or representations of the Brazilian Government in States of provenance of the participants who will have announced their participation in the meeting in advance to the UNIDROIT Secretariat will be notified by the Brazilian Ministry of Foreign Affairs in order to facilitate the issuance of the visa for participants.

Hotel accommodation

Neither the Brazilian Securities and Exchange Commission nor the UNIDROIT Secretariat can assist with the booking of hotel accommodation: this is a matter that participants will have to arrange for themselves.
