- 1. The budget for the 2014 financial year, approved by the General Assembly at its 72^{nd} session (Rome, 5 December 2013), provided for actual expenditure of \in 2,272,475.00 to be met by actual receipts of \in \in 2,272,475.00 with no balance being carried over from 2013.
- 2. The Accounts for the 2014 financial year indicate that actual receipts amounted to \in 2,111,515.17. Owing to an actual expenditure of \in 2,164,347,77, the cash account at the close of the 2014 financial year showed a balance of \in 36,557.82, resulting from \in 89,390.42 (carried over from the 2013 financial year) minus the negative credit balance in 2014 of \in 52,832.60.
- 3. Receipts and expenditures in the special accounts, amounting to \in 1,180.69, show a balance. The credit balance in the Working Capital Fund at the close of the 2014 financial year was \in 370,188.55.
