1. UNILAW – THE GATEWAY TO UNIFORM LAW INSTRUMENTS

1. A number of changes were made to the UNILAW database in the year 2009.

A. *Links*

2. It will be recalled that at its 88th session in 2009, the Governing Council endorsed a proposal first made to the Board of Governors of the *Uniform Law Foundation*, a prime funder of the UNILAW database, to add links to sites with uniform law instruments. This proposal and subsequent decision were made in recognition of the fact that the financial and staff resources available to UNIDROIT would not permit it to give full treatment to all uniform private law instruments. The desire to provide the international community with a gateway to uniform law was however such that it was decided that links should be provided to sites containing information useful to those consulting the database.

3. Work on the retrieval of the URL (Uniform Resource Locator) started very soon after the Council session. With the help of Ms Roberta MARRA, who worked at her home in Lecce as an extern for the database in period May to July 2009, the URL of both public and private law instruments were retrieved. In September, they were selected and classified by subject. It should be noted that the websites identified are all gratuitous. There of course exist a number of websites that offer information against payment, but it was observed that among those most requiring information on uniform law instruments

were people from developing countries, many of whom would have difficulty in paying the fees charged by commercial databases. In order to accommodate the needs of these people, and thus to offer a service to the international community as a whole in line with the vocation of an international organisation, it was decided that only gratuitous sites should be selected.

4. In order to accommodate the modifications required, the software also needed to be modified. The modifications of the Administration of the database (the site used to insert the materials) were completed by end October. Links to 352 instruments (348 + 4 to other languages of instruments dealt with in the database) had been inserted by the end of November, in several cases to a number of different languages.¹ Each instrument was linked to sites containing the text of the instrument, the status of ratifications, bibliography and cases (as available). The reason the information was divided into these four categories is that often more sites than one must be consulted to retrieve the information.² Once the links had been inserted, the software technician was able to work on the front end, i.e. the site visible to the public at large. By the time of the 89th session of the Governing Council all modifications will have been completed.

B. Full Treatment

5. If work on the database in past years was slow, an important reason was the need to prepare the structure of the database before it was possible to insert the materials. This involved the preparation and subsequent insertion of the issues, keywords, subjects and bibliographical areas for the different instruments to which full treatment was to be given: cases are linked to issues and keywords, bibliography to keywords and bibliographical areas, articles of the instruments to issues, keywords and subjects. The state of the preparation of these categories and their insertion as at February 2009 were given in summary form in Annex 1 to document C.D. (88) 16.

6. During the months May – September 2009 work continued with a view to completing the structure as soon as possible and at the same time to classifying and inserting the materials where possible. The table below gives the work completed in 2009 and the work planned for 2010 and following years:

7. At the end of September the Secretary-General decided that to avoid dispersion of resources the full treatment of instruments should be reserved to instruments prepared by UNIDROIT or on the basis of work carried out by this organisation. This meant not dealing with carriage by air and carriage by sea. The full treatment of these instruments would be replaced by links to sites of other organisations and institutions. The time between October 2009 and the 2010 session of the Council should be devoted mainly to recuperate the back-log of case summaries prepared for the CMR in past years by interns and other contacts. Should the Council be satisfied with the structure, progress and overall methodology of the database, the Council may wish to request the Secretariat to propose a method for prioritising, retrieving and classifying case law on instruments other than instruments prepared or resulting from work done by UNIDROIT (such as the Warsaw Convention, the Montreal Convention, the Hague Rules or the Rotterdam Rules) on the basis of an estimate of the amount of case law likely to be covered and the resources needed to proceed expeditiously and efficiently.

8. Work consequently concentrated on the editing of CMR case summaries and on their linking to relevant keywords and issues. It should be pointed out that in some cases the full text and basic references of a case (court, date, number, name of parties) had already been inserted, the summary being prepared subsequently. For this reason, more summaries have been/are being checked than the number of cases visible on the site have augmented.

9. It will be recalled that in February 2009, as specified in document C.D. (88) 16, p. 8, the number of cases on the CMR accessible to the public were 406. The summaries to check were 338³ and the cases collected pending selection and summary were 758.⁴

10. On 18 January 2010 the cases visible were 573, the summaries still to check were 176 and the number of cases collected pending selection and summary 814. The complete list is given in a pdf document available on the UNILAW site.

2. ASSISTANCE

A. *Experts*

11. As part of the optimization of resources, at the end of September the Secretary-General requested a survey to be made of the cases in, or being prepared for, the database with a view to ensuring that UNILAW contain all the most important cases (what in common law parlance are known as "leading cases").

12. The experts on the CMR that had met in Brussels in 2000, plus a couple of additional experts, were contacted and asked whether their country's cases collected by the Secretariat covered all the important cases. The experts contacted were: Professor Malcolm CLARKE (United Kingdom), Judge Michael ELMER (Denmark), Professor Krijn HAAK (Netherlands), Professor Rolf HERBER (Germany), Professor Cécile LEGROS (France), Professor Carlos LLORENTE (Spain), and Professor Jacques PUTZEYS (Belgium). Ms Roberta MARRA was asked to check Italy. All in all the response was positive. Some additional cases were identified and mostly sent by the experts, some were instead deleted as a consequence of their consideration that they dealt mainly with national carriage and domestic law.

B. Interns

13. In 2009 an experiment was conducted as regards the collaboration of students or young lawyers. UNIDROIT is not in a position to fund the stay of interns, at the most it is able to contribute in small part to the expenses faced by an intern who comes from abroad. In addition, the economic crisis has made it increasingly difficult for students to fund, or to find funding for, a stay in Rome. However, the contribution of interns is very precious to the UNILAW database. It was therefore decided that an attempt should be made to see if it were possible for the organisation to avail itself at a distance of the contribution of the would-be interns. The applicants were therefore asked whether they would consider an “externship”, i.e. conducting research at home and sending Ms Peters the results of their work by e-mail. They would receive an attestation to their work from UNIDROIT even if they stayed at home.

14. These “externships” were highly successful. The three externs were Ms Heejeong CHEUNG of the Korea University Law School (Seoul, Republic of Korea), Ms Roberta MARRA, University of Lecce (Italy), and Mr Erik SAPIN, American University, Washington College of Law (USA). Ms Cheung retrieved Korean cases on the *1929 Warsaw Convention* for which she prepared cases summaries. She also prepared a draft summary of the Korean Judicial System. Mr Sapin also worked on cases applying the Warsaw Convention.⁵ Ms Marra retrieved the internet URL for the great majority of instruments to which links were made (see above, paragraph 4). Ms Marra subsequently spent a few months in the UNIDROIT library starting October 2009, working on Italian case law on the CMR and assisting in the identification of the most important cases applying the Convention. A fourth extern is due to work in February in Kiev, retrieving Ukrainian cases on the CMR and preparing summaries for the database. A fifth will contribute case summaries from Azerbaijan, once he has returned to his country from a stay in Germany. In view of the success of the externship alternative, this extra possibility for students to gain credits recognised by their universities will be regularly proposed to would-be interns.

C. Secretariat

15. Ms Judit KISELY has been filling the post of assistant since May 2004. Her duties include the insertion of the texts, issues, keywords, subjects, bibliographic references, bibliography and status of ratifications of the different conventions. A substantial part of her work is to retrieve the full text of the cases dealt with, which means checking if an electronic version exists and if not scanning the case and proofreading it. Funding by the *Uniform Law Foundation* for the post occupied by Ms Kisely is gratefully acknowledged.

3. PUBLICISING AND MONITORING

16. At the 88th session of the Governing Council voices were raised stressing the necessity to monitor the usage of the database, indeed of all the electronic sources of information of the Institute. Consequently, the software technician was requested to arrange for an electronic monitoring system. This was done, and has been in place since July 2009. The findings indicate that there is interest, albeit less than there will be once the existence of UNILAW had been made public and publicised with above all universities. This has thus far not been done, as the Secretary-General felt that the Council should be the first to see the modified website of the database. UNILAW will therefore be publicised after the 2010 session of the Council. In the two months from 8 December 2009 to 9 February 2010 there were 2,052 visits to the site from 111 countries (1,417 from Europe, 260 from Asia, 250 from the Americas, 108

from Africa, 15 from Oceania and 3 not identified). 53.72% of visitors came through search engines,⁶ 36.18% from a referring site (including unidroit.org) and 10.09% as direct traffic.

17. To publicise the database information will be sent by e-mail to universities (university libraries and specialised institutes) and interested organisations (professional, non-governmental and inter-governmental). Internet browsers use a system known as “web crawling” or “spidering”. A “web crawler” is a computer program that browses the [World Wide Web](#) in a methodical, automated manner as a means of providing up-to-date data by downloading pages which the search engines [index](#) to provide fast searches.⁷ In fact, if “UNILAW” is used as a search word on a search engine, the database is already one of the hits (others include an association of European law firms and a Vietnamese law firm), albeit not in a sufficiently satisfactory manner. The Secretariat will endeavour to make the database more visible in the coming year, [including by means of an effective use of meta tags](#). A first attempt to do this has been to establish a link to UNILAW from the Wikipedia page on the CMR (10 February 2010).

4. FUTURE DEVELOPMENTS

18. In the course of 2010 work is expected to continue. The structure of the database is expected to be completed with the preparation of the issues, keywords, subjects and bibliographic areas for the *1988 UNIDROIT Convention on International Financial Leasing* and the *1988 UNIDROIT Convention on International Factoring* and work on CMR case law will continue. It is hoped that the externs will contribute both by summarising the important cases to which the experts have drawn the attention of the Secretariat, and by summarising interesting cases from less common jurisdictions. The Secretariat also intends to promote the database by informing universities and other institutions of its existence and of its utility for users looking for information on international uniform private law instruments.

19. *Council members are kindly requested to assist the Secretariat in identifying interesting and important cases applying the CMR, in contacting possible experts or externs who could assist in the preparation of case summaries, and in publicising the database in their countries.*
