<sup>1</sup> Bolivia currently owes UNIDROIT slightly more than ten years of statutory contributions. At its 71<sup>st</sup> session (Rome, 29 November 2012), the General Assembly decided that Bolivia would be regarded as a non-active member State, and followed the recommendation of the Finance Committee (70<sup>th</sup> session, 29 September 2011) that the Secretariat would no longer take account of the contributions owed by Bolivia in drawing up the budget for future financial years.

<sup>2</sup> Iran currently owes UNIDROIT two years of statutory contributions (not including 2013).

<sup>3</sup> The amount due by Pakistan represents the residual difference between contributions due and actual payments made since the financial year 1997. Apart from 1997, 2000 and 2004, Pakistan has always made annual payments, albeit rarely equal to the amount of its contribution. Currently, Pakistan owes UNIDROIT slightly more than one year of statutory contribution (not including 2013).

<sup>4</sup> Romania has been reclassified in 2012 in a higher Category of the chart of contributions to the UNIDROIT budget but paid the same contribution as in 2011. The amount due by Romania represents the difference.

<sup>5</sup> Serbia currently owes UNIDROIT one year of statutory contributions (not including 2013).
