### Item No. 3 Election of the Chair and Vice-Chairs of the Commission

3. In accordance with Rules 2 and 3 of the provisional Rules of Procedure, the Commission shall elect its Chair from amongst its Members, as well a first and a second Vice-Chair.

## Item No. 4 Consideration of matters relating to the appointment of a Supervisory Authority

4. <u>Resolution 2</u> of the Diplomatic Conference for the Adoption of the Draft Protocol to the Convention on International Interests in Mobile Equipment on Matters Specific to Mining, Agricultural and Construction Equipment (Pretoria, 11 – 22 November 2019) noted the active participation in the preparatory work and at the Diplomatic Conference by the International Finance Corporation (IFC) of the World Bank Group, and in the light of preliminary consultations with the said international financial institution, invited the governing bodies of the IFC to accept the functions of Supervisory Authority upon or after the entry into force of the Protocol, to take the necessary action in this regard, as appropriate, and to inform the Secretary-General of UNIDROIT accordingly.

5. Resolution 2 also established a six month time period for the IFC to make a decision in relation to whether to accept the role of Supervisory Authority, after which the Preparatory Commission would begin to consider the appointment of another International Organisation or entity as Supervisory Authority. Due to the challenges created by the COVID19 pandemic, which constituted a case of *force majeure*, likely to have affected the ordinary decision making-process of the IFC, the Preparatory Commission at its first session agreed that the period available to the IFC to accept the role of Supervisory Authority be extended until either 69 days after the end of the state of emergency in the United States of America or after the start of the Commission's next session, whichever occurred first.

6. The ongoing global pandemic situation continues and hence the circumstances which advised the suspension of the period envisaged in Resolution 2 remain. However, it seems at this stage uncertain for how long this situation will go on and the process to appoint a Supervisory Authority must continue. The UNIDROIT Secretariat deems the period of 69 days after the holding of the second Session of the Preparatory Commission sufficient and thus would propose that a decision be adopted to this end.

7. At its second session, the Preparatory Commission will hear an oral report by the UNIDROIT Secretariat regarding the ongoing discussions with the IFC. It will also consider a document containing research on other international organisations which could be considered for the role of Supervisory Authority.

# Item No. 5 Updates on the activities of the Working Group to develop draft regulations for the International Registry for MAC equipment

8. At its second session, the Preparatory Commission will be provided reports for the first two meetings of the Working Group established to develop draft regulations for the International Registry for MAC equipment. These reports shall be presented to the Commission by the Chair of the Working Group. The Preparatory Commission will also be provided with an updated version of the draft Regulations, as developed by the Working Group.
