1. The budget for the 2014 financial year, approved by the General Assembly at its 72nd session (Rome, 5 December 2013), provided for actual expenditure of € 2,272,475.00 to be met by actual receipts of € € 2,272,475.00 with no balance being carried over from 2013.
2. The Accounts for the 2014 financial year indicate that actual receipts amounted to € 2,111,515.17. Owing to an actual expenditure of € 2,164,347.77, the cash account at the close of the 2014 financial year showed a balance of € 36,557.82, resulting from € 89,390.42 (carried over from the 2013 financial year) minus the negative credit balance in 2014 of € 52,832.60.
3. Receipts and expenditures in the special accounts, amounting to € 1,180.69, show a balance. The credit balance in the Working Capital Fund at the close of the 2014 financial year was € 370,188.55.
