INTRODUCTION

1. In past years the different sources of information on the work of the Institute were managed separately. Over the years, however, the need for a greater co-ordination between them has increasingly been felt. Furthermore, the need to rationalise the resources available for these activities, both in terms of staff and in terms of financial resources, also calls for a review of the policy adopted.

2. In essence the sources of information are intended to promote knowledge of the Institute and the work it is conducting and has conducted in the past. However, while recognising the importance of the different information activities, the organs of the Institute are not in a position to match the meagre financial resources of the Institute to the importance of the activities. The challenge in the present economic climate is therefore how to engage in the very necessary activities promoting the organisation despite the lack of financial resources.

3. The sources of information can be divided by format: paper and electronic format. In some instances the divide between the different means is crossed (e.g. for the *Uniform Law Review* which exists both as a paper publication and as a database).

A. PAPER-BASED PUBLICATIONS

4. Traditionally UNIDROIT issues periodic publications (the *Uniform Law Review*, the *Proceedings and Papers*), as well as single volumes not part of a series (the *Guide to International Master Franchise Arrangements*, the *UNIDROIT Principles of International Commercial Contracts*). In some instances the Institute issues a publication in languages other than its working languages, albeit always in one of its official languages (the *Principles*, the *Guide*), but also enters into agreements with other individuals or bodies for their translation and publication. UNIDROIT also has a few distribution contracts in place (the *Principles*, the *Guide*).

(a) *Uniform Law Review*

5. On 1 July 2011, the Secretariat received an offer for the *Uniform Law Review* from Oxford University Press. The offer was not only for distribution, but also for editing and type-setting. The proposed duration of the initial agreement was five years. The OUP proposed an editorial structure with three pillars: an editor from UNIDROIT, an independent editor and a representative of OUP who would deal more with practical matters than with the actual content of the Review. As regarded the bilingual nature of the Review, OUP indicated that they already published multi-lingual reviews (English-French-Spanish), and that they therefore had editors for the French language as well as the English. On the basis of the data on distribution that the Secretariat had provided, OUP calculated that 130 free copies would be placed at the disposal of UNIDROIT. Furthermore, the reproduction of articles published in the Review for educational purposes (e.g. in University course materials) was no problem, and the posting of articles on the UNIDROIT website was also acceptable to OUP, although they suggested that how much and which might be discussed as the occasion arose.

6. The OUP offer also included an electronic version of the Review, which OUP would make available on-line in a way similar to what they have for other reviews. UNIDROIT currently has two electronic formats available for the *Uniform Law Review*: the agreement with HeinOnline, under which, against royalties, the content of the Review is placed on HeinOnline two years after publication, and the Review-database which is accessed through the UNIDROIT website (<http://ulr.unidroit.org/>). OUP suggested that the advantages offered by their site would justify a re-consideration of both these formats.

7. The annual cost of producing the *Uniform Law Review* in the year 2011 was estimated by the Secretariat at € 172,700.69 and can be broken down as follows:

8. The production cost of the *Uniform Law Review* is only partly off-set by the revenue from sales and royalties, which in the average of recent years amounts to little more than € 25,000, as indicated below:

By outsourcing the production and distribution of the *Uniform Law Review*, including editing, posting, billing, etc., while maintaining editorial control over the content of the Review, the Secretariat expects to achieve significant cost savings, which should permit a substantial re-allocation of resources under the regular Budget, including for promotion efforts and for new publications.

10. In 2011 Issues 1 and 2 were published as a double number with the reports on leasing submitted to the *XVIIIth International Congress of the International Academy of Comparative Law*, held at Washington (USA) from 25 to 31 July 2010, Section on Commercial Law. The session was chaired by Professor Herbert Kronke, former Secretary-General of UNIDROIT and member of the Advisory Board of the Review. Issue 2011-3 was devoted to the *UNIDROIT Principles of International Commercial Contracts 2010*, with contributions from the *rapporteurs* and from a number of other experts. Issue 4 is under preparation at the time of writing and will be a general issue, containing the reports on the activities of UNIDROIT, UNCITRAL and the Hague Conference, as well as the Uniform Law Bibliography and a certain number of miscellaneous articles.

11. In 2012 Issues 1 and 2 will again be a double number, with the acts of the *UNIDROIT Colloquium Promoting Investment In Agricultural Production: Private Law Aspects* (Rome, 8-10 November 2011).

12. Annexes 1 – 3 of this document give statistics on the distribution of the *Uniform Law Review*. The data for 2012 are as at 15 February 2012 and are therefore partial. It should be noted that the different categories for the distribution of the Review are sale, exchange (for periodicals in the Library holdings), Depository Library and gift.

(b) *UNIDROIT Proceedings and Papers*

13. For many years UNIDROIT documents have been issued year by year as a bound volume entitled "*UNIDROIT Proceedings and Papers*". The volumes have been sold, in particular, to a number of libraries. However, over the years sales have dwindled and are now down to 9. The revenue from the sales is still € 1,179.00, but is likely to dwindle even further as the documents are available on the UNIDROIT website.

14. The *Proceedings and Papers* were also issued as CD-ROM that were cumulative and distributed to select persons (notably the members of the Council).

(c) *UNIDROIT Principles of International Commercial Contracts*

15. The *UNIDROIT Principles of International Commercial Contracts 2010* were published in June 2011 in English and in August 2011 in French. Although no massive campaign has yet been conducted, the English version is selling well (see Annex 3). It is the intention of the Secretariat to conduct a marketing campaign (by electronic means) as soon as the pertinent e-mail addresses have been collected.

16. In addition, the Secretariat is negotiating a distribution agreements for Canada and is investigating the possibility of a distributor for France. In Australia, the Federation Press still acts as distributor for UNIDROIT publications.

(d) *Official Commentary to the 2009 Convention on Intermediated Securities*

17. An agreement was concluded with Oxford University Press under which the English version of the Official Commentary to the 2009 Convention on Intermediate Securities became a title in the OUP catalogue. It is a collective work, the authors of which (Hideki Kanda, Professor of Law, University of Tokyo; Charles W. Mooney, Jr., Charles A. Heimbold, Jr. Professor of Law, University of Pennsylvania; Luc Thévenoz, Professor of Law, University of Geneva; and Stéphane Béraud, Head of the European and Financial Markets Law Division, Legal Services, Banque de France) have granted the Institute copyright. Negotiations are underway for the publication of the French version of the Commentary in the series "*Publications du Centre de droit bancaire et financier*", published jointly by *Schulthess, LGDJ* and *Thémis*.

(e) *UNCITRAL, Hague Conference and UNIDROIT Texts on Security Interests*

18. In February 2012, an agreement was signed by UNIDROIT, UNCITRAL and the Hague Conference for the publication of a volume on the instruments prepared by the three organisations on security interests: "*UNCITRAL, Hague Conference and UNIDROIT Texts on Security Interests*". The volume will be published by the United Nations which will hold copyright. Authors of the volume are Professor Neil Cohen of Brooklyn Law School (New York) and Mr Steven Weise, Attorney-at-Law (Los Angeles).

B. ELECTRONIC SOURCES OF INFORMATION ON UNIDROIT

(a) *UNIDROIT Website*

19. The UNIDROIT website was designed early in the 1990's thanks to the foresight of Ms Paula Howarth, who acted as web administrator until her retirement on 1 January 2012. Over the years, the website has proved to be the best and easiest introduction to the organisation. Indeed, an effective and as comprehensive a site as possible is essential for any organisation or institution seeking to become known worldwide. Occasionally, however, it is necessary to modernise the technology used to create the site, to add features or to modernise the presentation of the materials. A new website is currently under study and is expected to replace the current site in a year's time. Such a lengthy procedure is necessary due to the fact that it will be done in-house, by staff also otherwise engaged, and because of additional features, such as the creation of a new database section or part for the instruments adopted by the organisation, intended to replace both the section on conventions of the website and the UNILAW database. The complexity of this procedure is such that careful planning is required, with all the links and insertion procedures worked out and tested. A certain rationalisation of the different items currently on the website will also be made (e.g. *Proceedings and Papers* will only be part of *Publications*).

20. Statistics on consultation of the UNIDROIT website are available from Google Analytics. In the period 1 May 2011 to 21 February 2012, 57,187 people from 183 countries visited the UNIDROIT website, 65.33% of which were new visitors. Most visitors came from Italy (13,241), followed by the United States (6,533), Mexico (4,338), the United Kingdom (4,190), France (3,607), and Russia (3,461) (for a full list, see Annex 5). 57.65% of visits were the result of search traffic, 12.81% was referral traffic and 29.55% direct traffic.

(b) *UNILAW*

21. At its 90th session, the Governing Council confirmed the decision that UNIDROIT should provide text search, case law and bibliographical information only on instruments prepared by the Institute, while treatment of instruments prepared by other organisations should be limited to the provision of links to websites that publish their texts and status of implementation. Consequently, it agreed that the level of information to be provided on instruments adopted by other organisations on the basis of work carried out by UNIDROIT (such as the *Convention on the Contract for the International Carriage of Goods by Road (CMR)*) needed to be reconsidered and that, in view of its limited resources, UNIDROIT should no longer maintain the case law section in respect of the CMR. By means of the good offices of Professor Jacques Putzeys, former member of the Governing Council, an agreement was reached with the *Institut du droit international des transports (IDIT)* under which the IDIT took over the section of the UNILAW database dealing with the CMR, including the case law and the bibliography, with a view to hosting the section on their website. As a consequence of the work on the database necessary with a view to the transfer of the CMR to the IDIT site, work on the database section on the CMR stopped at the end of 2011. The other sections require little maintenance and were updated as required.

22. As indicated above, a restructuring of the UNIDROIT website is under study and will incorporate the remainder of the material currently on the UNILAW site.

23. The statistics furnished by Google Analytics indicate that in the period 1 May 2011 to 21 February 2012, 8,879 people from 157 countries visited the UNILAW site (see Annex 6 for a complete list). 11,704 visits were paid, and 48,838 pages viewed. Most visitors came from France (1,815), followed by Italy (1,021), Belgium (895), the United States (599), Poland (537), Germany (488) and China (480). Of the visits, 46.11% originated as search traffic, 38.34% as referral traffic, and 15.55% as direct traffic.

(c) *Uniform Law Review*

24. As indicated above, the *Uniform Law Review* has two electronic formats at its disposal. The first is a database accessed through the UNIDROIT website (<http://ulr.unidroit.org/>). It is not a site which simply reproduces the articles in the Review as pdf documents, it offers certain search possibilities (e.g. by keyword). Secondly, an agreement is in place with HeinOnline under which they publish the Review on their website two years after the paper version is issued. The Institute collects royalties for the consultation of the Review. For 2010 the royalties were USD 3,335.12 (€ 2,507.42). At the time of writing the royalties for 2011 have not yet been communicated. The progression of royalties was: 2006: USD 317.34 (€ 251.17); 2007: USD 4,323.58 (€ 3,165.60); 2008: € 2,899.08; 2009: € 2,309.72; and 2010: USD 3,335.12 (€ 2,507.42).

C. DEPOSITORY LIBRARIES

25. Currently there are 52 Depository Libraries in UNIDROIT member States, a few countries having more than one (see Annex 7 for a complete list). Not all Depository Libraries receive everything issued by the organisation: when they adhered to the scheme they were asked what they were interested in and on the basis of their reply they were sent materials. For example, out of the 52 Depository Libraries only 31 receive the *Uniform Law Review*.

26. To a large extent the idea of Depository Libraries has run its course: with the documentation increasingly being made available on the website of the organisation, which is accessible from most, if not all, countries of the world, the utility of paper-based copies or CD-ROM is questionable.

27. Having, or being, a Depository Library may of course have a role for the institution concerned beyond that of being able to offer users access to the documents, in that it may enhance the importance of the institution. It is therefore also a matter of prestige and this fact should be taken into consideration when the utility of Depository Libraries for an organisation such as UNIDROIT, which does not produce an enormous amount of documents, is considered.

D. THE FUTURE

28. The resources available to UNIDROIT have dwindled steadily over the past few years. The possibilities of finding funding from other, private, resources are also not encouraging and would require an effort and investment in time which the staff of UNIDROIT do not have at their disposal. However, if the organisation is to be able to take its rightful place among international organisations, it must make a great effort to make itself known. The first actions could be the following:

Co-ordination	A great effort must be made to increase the co-ordination of the different information activities of the Institute, with procedures put in place designed to render this co-ordination and management smooth and economical in terms of time-consumption.
Website	With the preparation of a new, more modern website, the possibility of making more information available, and of organising it in a more user-friendly way, opens up great possibilities. To the greatest extent possible, duplication should be avoided, with the exception of when it is either necessary or justified.
Archive	All older material and documents could be housed in a special Archive of the website. This would include all the documents produced by the organisation throughout its history (what are known as the "Green books"). A photographic archive, with photographs of the big events in the history of the organisation, could also be opened.
UNILAW	By making the information and material currently available on the UNILAW website accessible on the UNIDROIT website the ambition is to render it more interactive with the other sections of the website. The database part of a new website would not be as sophisticated as the current database, whether or not that degree of sophistication would be necessary needs to be assessed.
Marketing	Over the past months the Secretariat has been retrieving the electronic addresses of possible recipients of electronic publicity for the publications and activities of the Institute, classifying them by area of interest. These addresses can be used for repeated, periodic electronic mailings.

Papers and Proceedings	The utility of this publication seems to have run its course, both as regards distribution to Depository Libraries and as regards sales. However, since it may be possible that a recipient needs the publication either on paper or as a CD-ROM, one possibility could be to issue it as a publication-on demand, in the same way that a number of books are available only "on demand" from publishers.
Other publications	The utility of the formula "on demand" for other publications, and the possibility of electronic versions only (payment as with e-books generally), need to be studied.
Depository Libraries	Also the utility of the Depository Libraries seems to have come to an end, as UNIDROIT documentation is available on line. However, given the political implications, their utility should be carefully assessed.
Uniform Law Review	If the <i>Uniform Law Review</i> were to be produced and marketed by the Oxford University Press, this would free resources, both staff and financial, that could be used for other purposes. In addition, the possibilities the OUP have for marketing the Review would be likely to increase sales in countries normally not reached by the Institute. An evaluation must be made of these advantages against the less freedom in managing and distributing the Review that would necessarily follow.

CONCLUSION

29. The limited financial and staff resources available to the organisation for information and promotion activities call for greater co-ordination and rationalisation. The Secretariat has started on this path and is committed to continuing and perfecting both co-ordination and rationalisation. It is also committed to examining and assessing the utility for the purposes of UNIDROIT of new modern electronic means as they develop. As with all modernisation, it is a process that cannot be completed over night and that requires careful planning. It also requires the political support of the organs of the organisation, Governing Council and General Assembly first and foremost.

30. *In the light of the above, the Governing Council is requested to take note of the actions conducted so far and to endorse the proposals submitted by the Secretariat.*
