### **Item No. 1 – Opening of the session and welcome by the Chair of the Working Group and the Secretary-General**

1. The fourth Working Group session will be held in hybrid format starting at **10:00 CEST on 26 April 2022** and ending at **13:00 CEST on 28 April 2022**. A more detailed schedule is suggested below, under Item 3.
2. The session will be held at UNIDROIT's premises (Via Panisperna 28 – 00184 Rome, Italy). A light lunch will be offered at UNIDROIT at 13:00 CEST on Wednesday, 27 April 2022, in order to allow the Working Group to resume its deliberations at 14:00 CEST.
3. A link to join the session will be sent to remote attendees prior to the meeting. There will be an opportunity to test the connection before the beginning of the meeting.

### **Item No. 3 – Adoption of the agenda and organisation of the session**

4. It is proposed that discussions be generally held as follows:
