2023 SCHOLARSHIPS - CALL FOR APPLICATIONS

Applications due 30 September 2022

Introduction

- 1. The International Institute for the Unification of Private Law (UNIDROIT) Scholarship, Internship and Research Programme is currently accepting applications for scholarships to be undertaken in 2023.
- 2. A limited number of research scholarships (1000€ per month) will be granted to outstanding post-graduate (doctoral) law students, lawyers, academics and government officials to undertake two months of research in the UNIDROIT library (exceptionally, scholarships can also be granted for three months). Candidates that are unsuccessful in applying for a funded scholarship may instead be invited to undertake a research stay at UNIDROIT on an unfunded basis.
- 3. During their research period at UNIDROIT, Scholars may be invited to deliver a short workshop on their topic. Following their research period, scholars are encouraged to consider submitting a paper to the Uniform Law Review for publication (https://academic.oup.com/ulr).
- 4. All scholarships must be undertaken in-person at the UNIDROIT Headquarters in Rome, Italy.

Research areas

- 5. Candidates may apply for scholarships in relation to any of UNIDROIT's work areas, existing instruments or current projects.
- 6. To support the Unidensit 2023 2025 Work Programme, special consideration will be given to applications for scholarships relating to the following topics (candidates may indicate their interest in researching matters related to more than one work area or project):

1. Secured Transactions

- a. The <u>Cape Town Convention</u> and its <u>Aircraft</u>, <u>Rail</u>, <u>Space</u> and <u>Mining</u>, <u>Agricultural and Construction (MAC)</u> Protocols;

Application process

- 7. To apply for a scholarship, candidates must submit the following documents in English or French:
 - (i) Completed application form (https://www.unidroit.org/research-and-internships/)
 - (ii) Short cover letter
 - (iii) Curriculum Vitae (CV)
 - (iv) Reference letters
- 8. In their application form, candidates are asked to nominate one or more 2 3 month period in 2023 during which they would intend to undertake their scholarship.
- 9. Candidates will be assessed on their cover letter, CV, research proposal, the value of the research to Unidroit, English/French proficiency and references.
