### The Concept

Broadly speaking, an investment-friendly legal framework requires (i) an efficient adjudicating framework, including a reliable judicial system as well as a well-functioning arbitration and other alternative means of dispute settlement; (ii) a state of the art, stable, and reliable market regulation; and (iii) procedural efficiency. International standards play a decisive role in reaching such goals, since they help coordinate and attain common targets and principles, while simultaneously allowing for tailor-made solutions at national level.

In this event, the discussion will focus on the critical issues that need to be addressed in order for a legal order to truly become investment-friendly, and how international standards, as produced by a number of standard-setting bodies and international organisations, help and could support such a process even further. Representatives of the Italian business and arbitration communities will contribute with concrete experiences and open issues. It will be our privilege to welcome The Honourable Paul Lam, SBS, SC, JP, Secretary for Justice of the Hong Kong Special Administrative Region of the People's Republic of China, to illustrate the relevant policy choices made by Hong Kong to that end.
