Introduction

The seminar is addressed to international lawyers and In-House Counsel who wish to deepen their knowledge on the impact of the law applicable to the contract on its performance, taking as core example the legal and contractual remedies available in case of breach of the contract by the other party. The choice of law made during the negotiation phase of a contract determines the party's options for reacting to subsequent breaches. Unfamiliarity with the applicable law may prevent a party from using the instruments known to them from

their national law. In the context of the centenary since the foundation of UNIDROIT, we will present the rules of international substantive law, CISG, and UNIDROIT PICC, as an alternative to the laws of individual countries, enabling reliable and safe contracting in international trade. Within such framework participants will analyze and discuss possible contractual solutions and will be actively involved in workshops to implement the parties needs through clear and effective contract drafting.
